- 6) Other

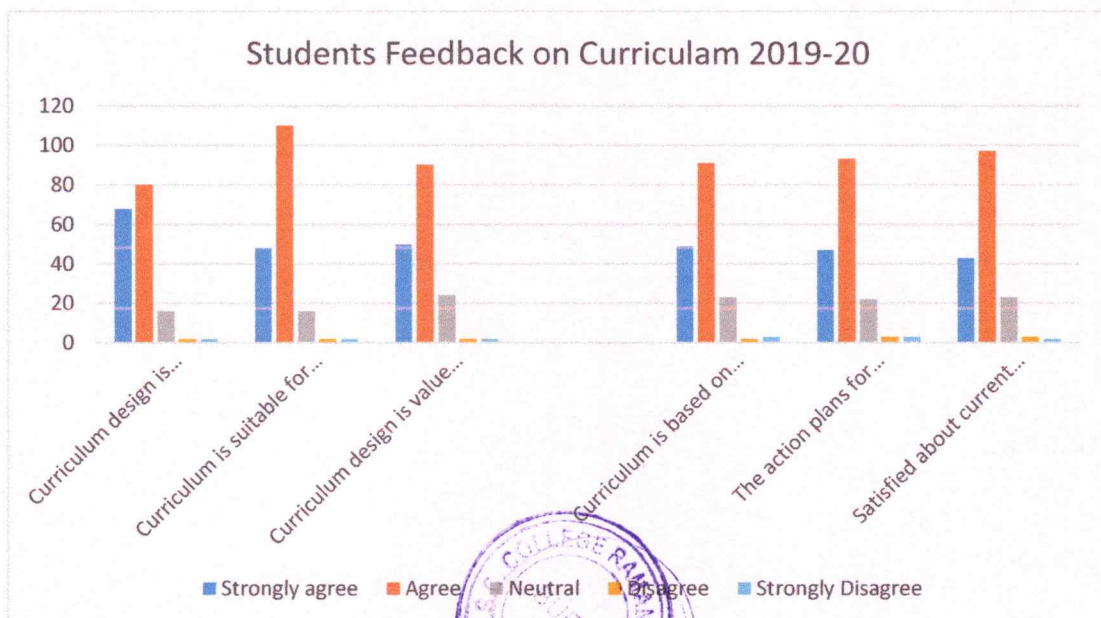
**Student Feedback:**



2. Use more PPTs and Educational videos while teaching.



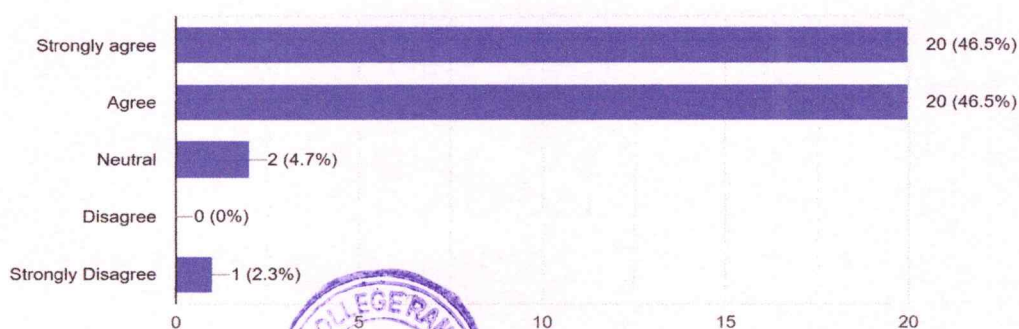

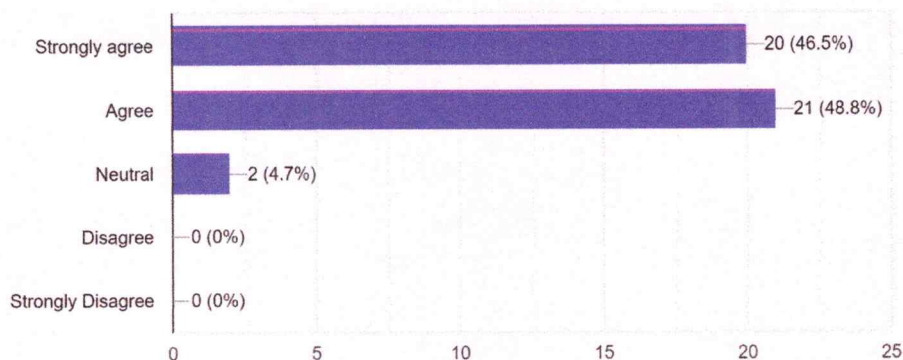

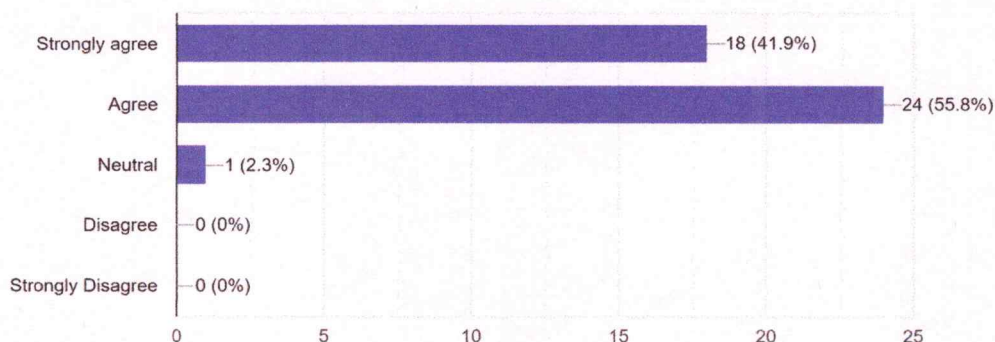

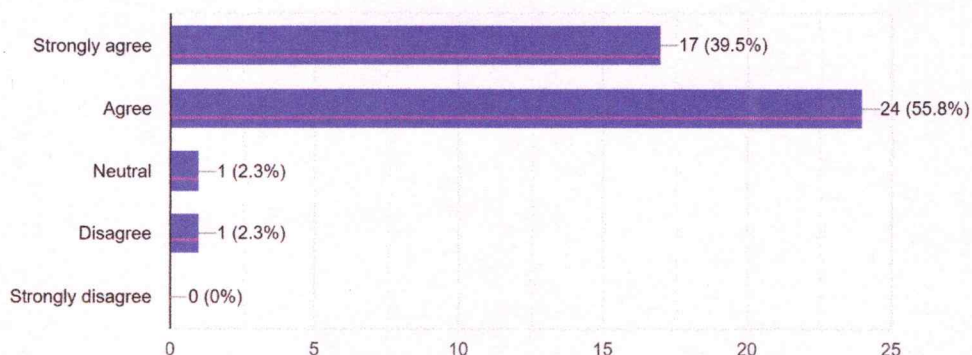


The above graph shows 41.9% responses are strongly agree, 55.8% are agree, 2.3% are neutral and 0% responses are disagree and strongly disagree.

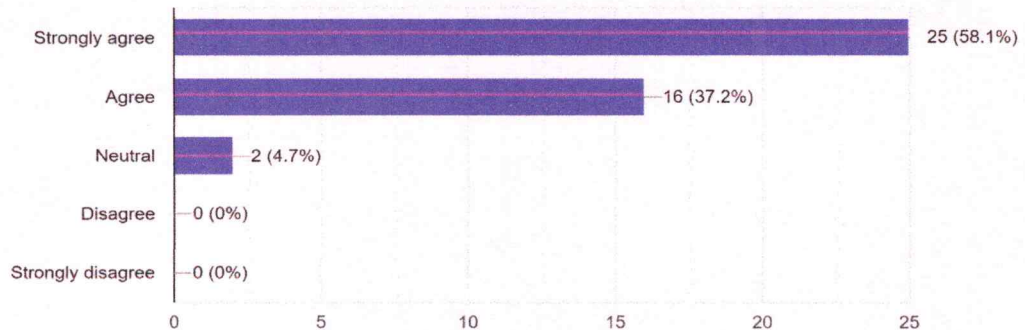

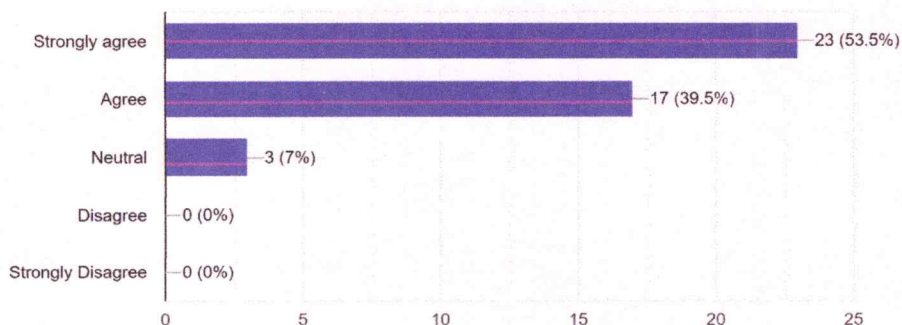

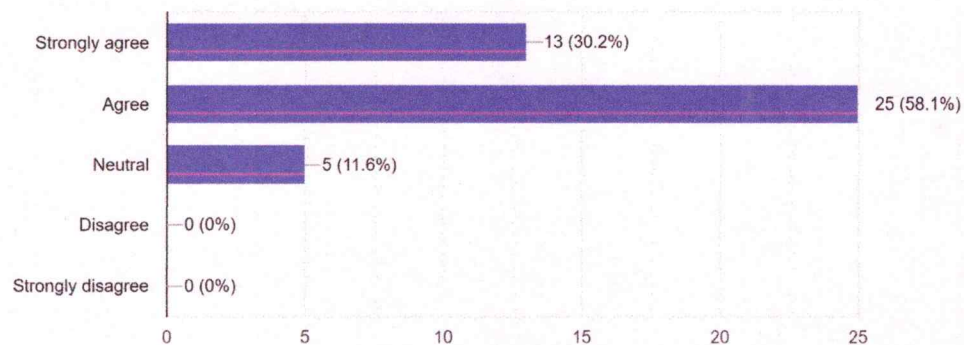

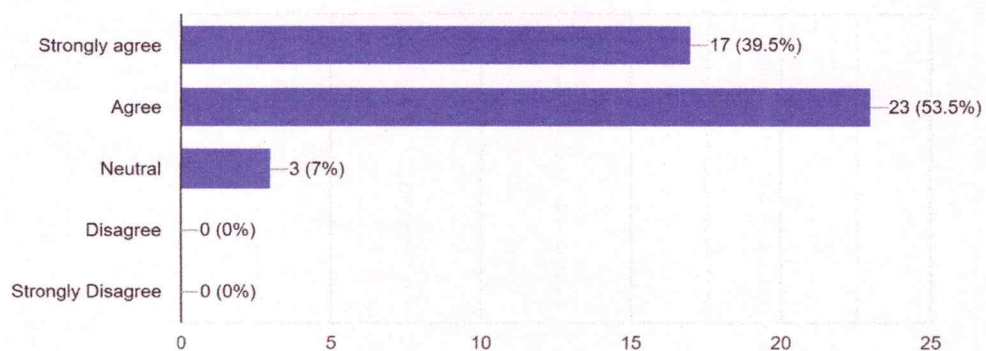

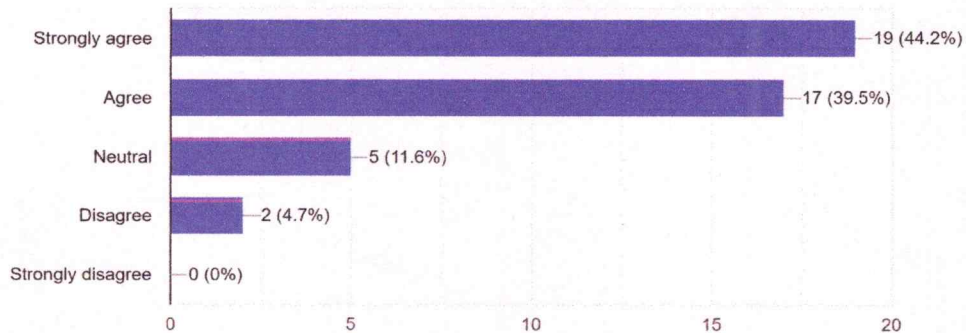




❖ **Infrastructure facilities, such as teacher's rooms/carrels, class rooms, reading rooms and toilets are available in the department.**

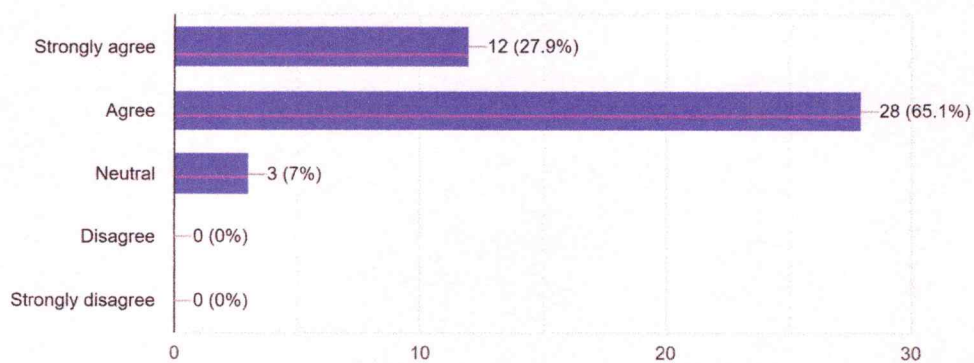

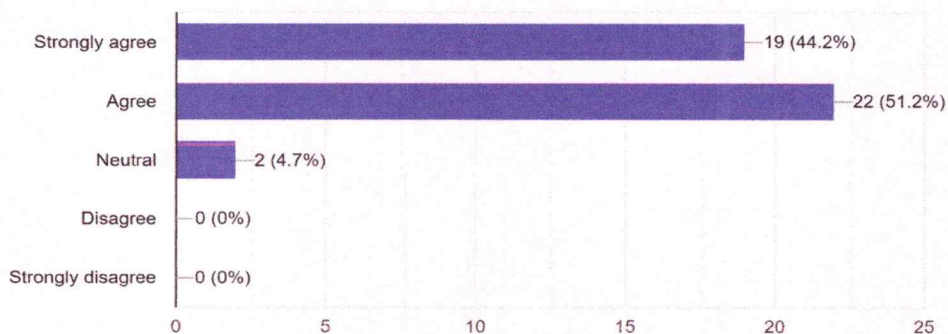

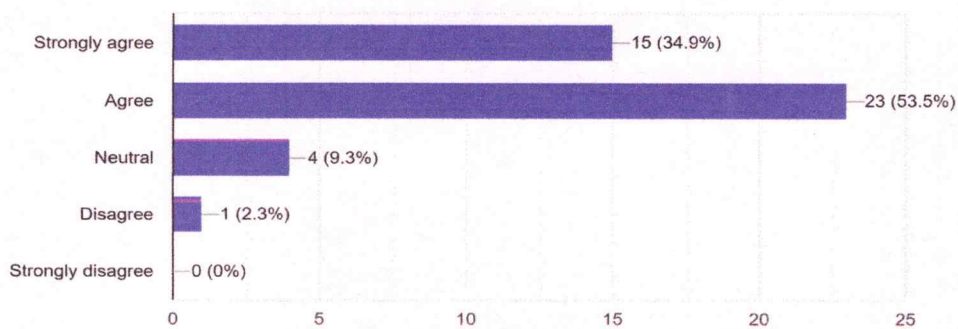

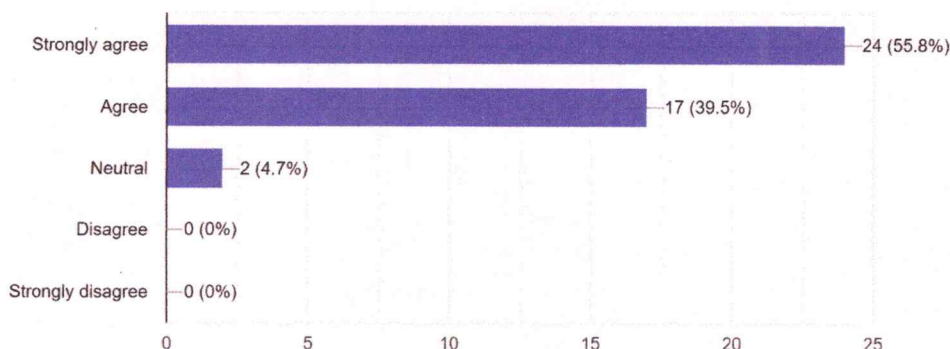

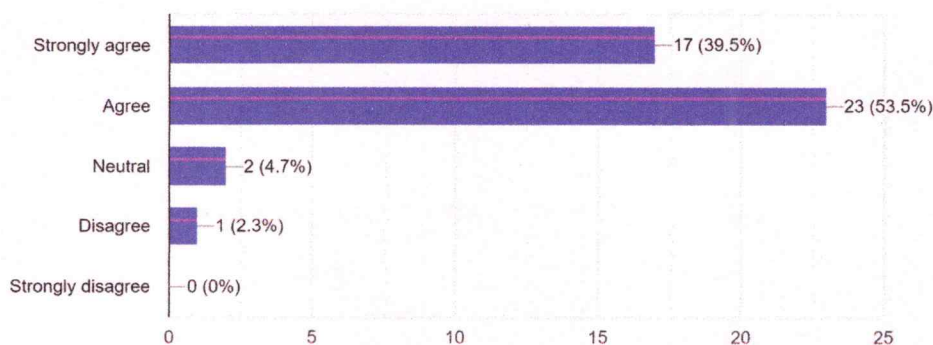

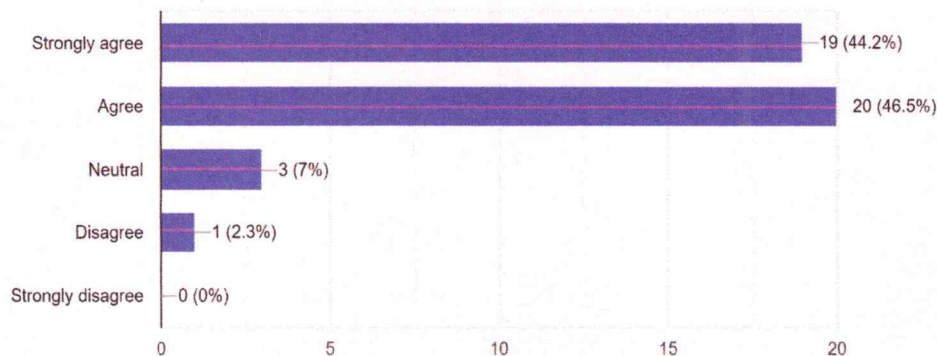

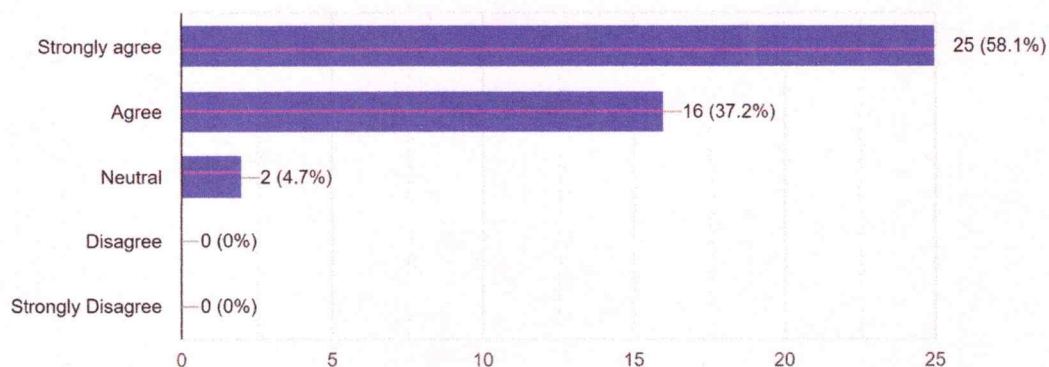

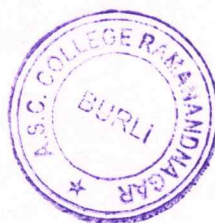

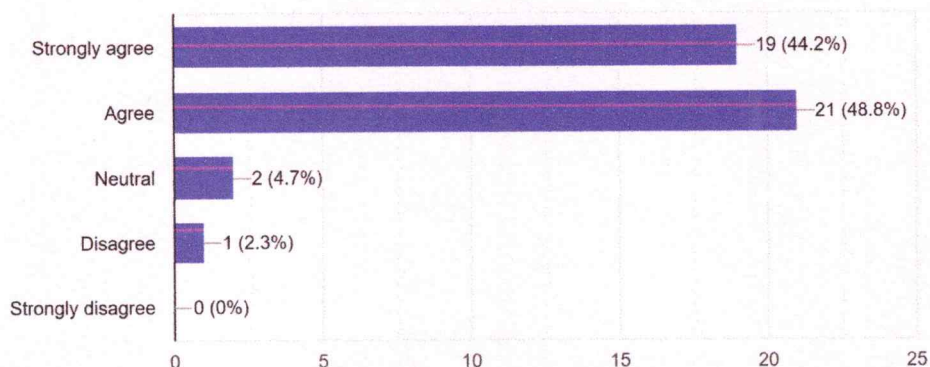

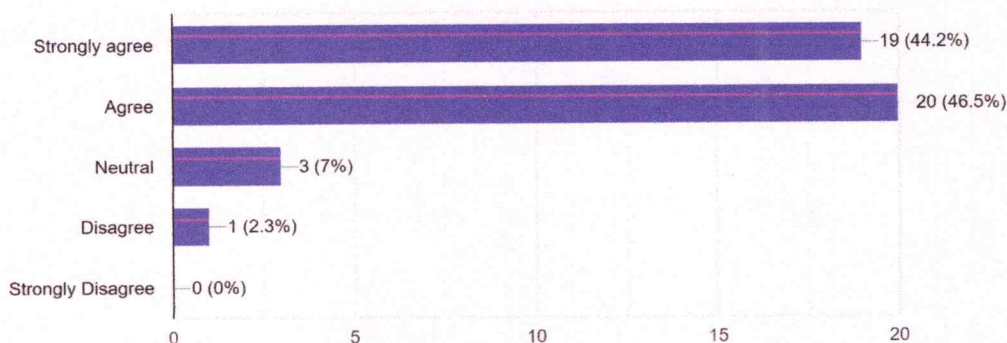

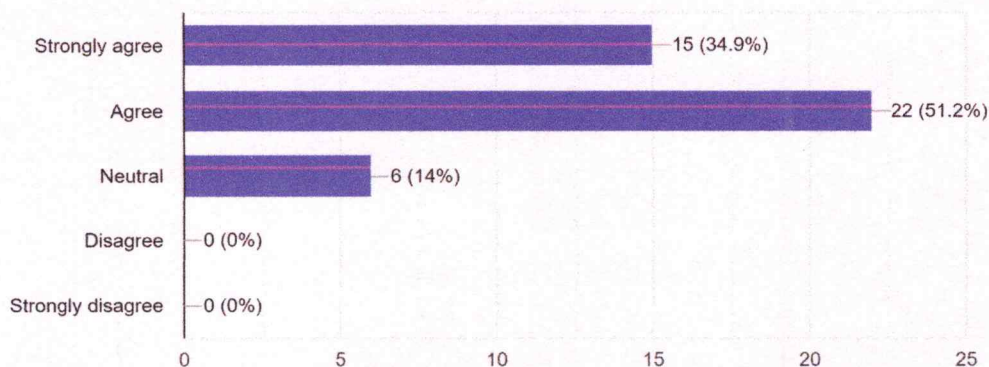

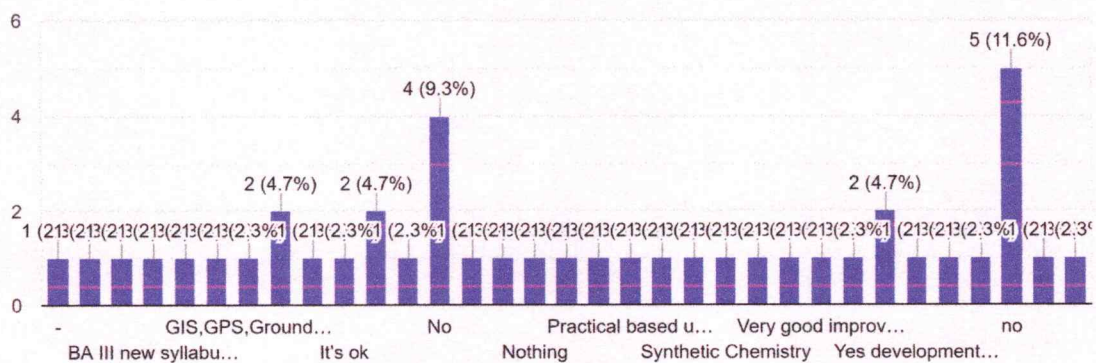
