- 6) Other






# Report on, Teacher's feedback on Curriculum





The above graph shows 34.7% responses are strongly agree, 49% are agree, 6.1% are neutral.


























The above graph shows, 40.8% responses are strongly agree,46.9% are agree 8.2% responses are neutral ,2% are disagree and strongly disagree respectively.








